The Rochester Education Foundation is an independent organization whose mission is to provide programs and resources to improve learning and success for all Rochester city public school students through partnerships with educators, businesses and the community.

Student Literacy: REF has primarily supported literacy development through the Teachers' Choice program. Through Teachers' Choice, educators can apply for up to 200 new books for a creative project outside of their normal curriculum. At the end of the project, students keep the books to build their home libraries. During the 2020 school year, REF provided 680 books to teachers through Teachers' Choice. Seeing the immense need for reading material in students' homes during the Pandemic, REF extended their support to include used books. As a result, over 12,000 books were distributed to students from March to December 2020.

4b (Code:) (Expenses \$ 72,468. including grants of \$) (Revenue \$)

Arts Education: In 2003, REF launched the Spring For Music program in response to drastic cuts to music funding in the City School District since its launch, Spring for Music has provided over 3,000 instruments to classrooms and musicians. Over the years, REF has expanded Spring for Music into Spring for Music and Arts Opportunities- providing key resources for students to receive supplemental lessons, perform, and more. This support encompasses visual arts, theater, dance, and music. During 2020, REF provided support for the production of the musical Frozen, Jr., provided instruments for students, and sponsored students to receive virtual lessons during the summer.

4c (Code:) (Expenses \$ 144,581. including grants of \$) (Revenue \$)

College Access: REF leads a community initiative, Rochester College Access Network, which brings together higher-ed institutions, community organizations, counselors, and community members to set community goals around college-going and align resources to break down the barriers city students face on the road to post-secondary education. Prior to the Pandemic, REF staff were providing weekly in-school FAFSA support for students and coordinating community FAFSA completion events. Since the Pandemic, support has been shifted virtually- coordinating remote FAFSA-Thon completion events, providing on-demand college counseling assistance through the online College Help Desk, and delivering workshops on a variety of topics.
