1 Briefly describe the organization's mission: The Rochester Education Foundation is an independent organization whose mission is to provide programs and resources to improve learning and success for all Rochester city public school students through partnerships with educators, businesses and the community.

The Organization is involved in the Childhood Healthy Weight Initiative of the Greater Rochester Health Foundation as a sub-contractor for project coordinators, supporting five consultants at city schools. The goal of the program is to increase the percentage of 4 to 10 year olds in the city who are at a healthy weight by increasing healthy eating habits and physical activity.

4b (Code:) (Expenses \$ 38,789. including grants of \$) (Revenue \$) Give Back, Give Books: The Organization supports student book clubs, parent-student reading events and a wide range of literacy projects for city students through Teachers' Choice, a program within Give Back, Give Books. The Organization has given more than 37,000 new books to city students for reading activities in class and to enjoy at home since 2006. In 2015 the Organization provided up to 200 new books to each of 24 educators in city schools. Books are then given to students for their home libraries. The Organization also supported summer reading through RocRead.

This program is primarily supported through contributions.

4c (Code:) (Expenses \$ 46,032. including grants of \$) (Revenue \$ 42,619.) REF's 2015 Law Prep summer program provided 30 Rochester youth, ages 14 to 18, with information about careers in the law. The program worked with the students to develop the knowledge, skills and attitudes necessary for successful professional careers.
